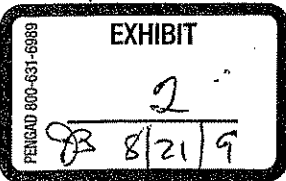



After Miranda per card, Def was unable to dispell my Alarm and explain what he was doing looking into cars including my vehicle. After Def was handcuffed while I was moving my vehicle Def ran with handcuffs on from ofc Forte. I was able to catch up to Def in my vehicle and while he was running he lost balance and fell to the ground and suffered minor scrapes on his arms. Def arrested and transported to MRPD.
