

**RESOLUTION NO. 2022-14**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF JACKSON COUNTY, FLORIDA; AMENDING DISTRICT LINES FOR THE JACKSON COUNTY BOARD OF COUNTY COMMISSIONERS' DISTRICTS BASED ON 2020 CENSUS DATA; PROVIDING FOR FINDINGS THAT THE COMMISSIONERS' DISTRICT LINES ARE CONSISTENT WITH REDISTRICTING REQUIREMENTS AND TRADITIONAL REDISTRICTING PRINCIPLES; PROVIDING A MAP OF THE COMMISSIONERS' DISTRICT LINES; PROVIDING BOUNDARY DESCRIPTIONS OF THE COMMISSIONERS' DISTRICT LINES; PROVIDING A POPULATION DISTRIBUTION TABLE OF THE COMMISSIONERS' DISTRICTS ; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Fla. Const. Art. VIII, sec.1(e) and § 124.01, Fla. Stat., the Board of County Commissioners shall redistrict the commissioners' districts into areas of contiguous territory and into districts as equal in population as possible; and

**WHEREAS**, redistricting is vital to maintaining the constitutional doctrine of one person, one vote; and

**WHEREAS**, Fla. Const. Art. VIII, sec. 1(e) requires the Board of County Commissioners to redistrict the commissioners' district lines following each decennial census; and

**WHEREAS**, the 2020 Census data has been distributed; and

**WHEREAS**, a redistricting plan should reflect traditional redistricting principles which can include geographical compactness, contiguity, preserving incumbents and preserving groups of similar political ideologies; and

**WHEREAS**, Jackson County is a party to prior litigation regarding its districts in the matter of James H. Glenn, et. al., vs. Jackson County, Florida, et. al; Northern District of Florida Case No. 84-2110-RV.

**NOW THEREFORE BE IT RESOLVED**, by the Board of County Commissioners of Jackson County, Florida, that


1. The commissioners' districts illustrated on the map attached hereto as Exhibit "A," and further described in the district boundary descriptions, attached hereto as Exhibit "B," are based on the 2020 Census of Population data and are consistent with the redistricting requirements of Art. VIII, sec. 1(e) of the Florida Constitution, pertinent state statutes and the Federal Voting Rights Act of 1964, as amended, which prohibits political jurisdictions

from imposing any voting procedure that dilutes the voting strength of racial or ethnic minorities.

2. The commissioners' districts illustrated on the map attached as Exhibit "A" and described in the district boundary descriptions attached as Exhibit "B" reflect districts based on traditional redistricting principles such as geographical compactness, contiguity, preserving incumbents and preserving groups of similar political ideologies.
3. The commissioners' districts illustrated on the map attached as Exhibit "A" and described in the district boundary descriptions attached as Exhibit "B" comply with those conditions identified in that Amended Final Judgment rendered April 11, 1986, in James H. Glenn, et. al., vs. Jackson County, Florida, et. al. (Northern District of Florida Case No. 84-2110-RV).
4. The commissioners' districts of Jackson County, Florida, shall be those shown on the map attached hereto as Exhibit A, and incorporated herein by reference and comprised of the contiguous territories illustrated on said Exhibit A, and further described by the district boundary descriptions attached hereto as Exhibit B and incorporated herein by reference. The population distribution of these districts, as established by the 2020 Census data, is illustrated in the population distribution table attached hereto as Exhibit C and incorporated herein by reference.

COUNTY COMMISSIONER DISTRICTS


