MESSAGE FROM THE FRONTLINE

October Edition

As we look toward the close of 2025, we find ourselves in a defining moment for democracy — not just in Florida, but across our nation. Our democracy is being tested — not by a single law or leader, but by the creeping belief that power belongs only to the powerful, and that ordinary people can do nothing to stop them. We reject that lie.

The truth is, America has been here before. Nearly 250 years ago, a group of men declared that tyranny was intolerable — even as they built a nation on stolen land and the enslavement of other human beings. Their words were imperfect, but the idea they unleashed — that all people are created equal and endowed with unalienable rights has been reimagined and made real by those they excluded.

It is the descendants of the enslaved, the immigrants, the teachers, the workers, the dreamers — the everyday people — who have carried this promise forward. Every expansion of freedom has come not from the halls of power, but from the courage of those who refused to be silent.

Today, that torch is in our hands. We see the same forces of tyranny at work: attempts to silence teachers, erase history, criminalize protest, restrict voting, and redraw maps to divide our communities. But we also see the same courage that has always defined this movement. We see it in students demanding honesty in education. In voters who know that their voices matter. In communities organizing for equality for our LGBTQ+ neighbors, dignity for immigrant families and pregnant people, and equal protection under the law for all — even when their voices challenge those in power.

The same courage that fueled revolutions, marched across bridges, and desegregated schools lives on in us. It reminds us that democracy is not a spectator sport — it is a collective act that requires commitment. And when we move together, history bends toward justice.

Dr. King once asked, "Where do we go from here — chaos or community?" In Florida, we have answered: we choose community. We choose courage. We choose democracy. Because this is not the end of our story — it is the moment when we rise to write the next chapter.

So yes, the stakes are high. But the power is ours. We will not surrender truth to propaganda or freedom to fear. We will stand up, speak out, and defend the rights that belong to all of us.

Because we are the people who refuse to be silenced. Because we are the movement that keeps marching forward.

Because we are the frontline of resistance.



Free Speech Under Fire: Florida's Leaders Are Silencing Public Servants — We're Fighting Back

When a government punishes its own employees for lawful speech, democracy itself takes the hit. That's what happened to Brittney Brown, a respected biologist with seven years of service at Florida's Fish and Wildlife Conservation Commission. Her "offense"? A temporary social media post about the tragedy of school shootings that referenced the death of Charlie Kirk on her private account. The post did not condone Mr. Kirk's killing nor did it call for further violence; rather, it conveyed a satirical indifference — a viewpoint fully covered by the First Amendment.

Yet her temporary 24-hour post was screenshotted from her private account and later uploaded to X by an account called "Libs of TikTok," which shared a screenshot of Brown's post next to a screenshot of her LinkedIn profile. The post called for her immediate termination at the state agency. Within 24 hours, FWC wrongfully complied and terminated Brown — violating her First Amendment rights.

This case isn't an outlier. It's part of a broader pattern of state leaders using fear and political loyalty tests to police speech, from classrooms to workplaces. Brown's firing is just another extreme example of how Florida's leadership pressures and seeks to exact revenge against state workers with differing political views. For the past several years, the state has employed a wide range of tactics to chill or censor speech across state entities and programs. Just earlier this year, Gov. DeSantis called for a DOGE audit to "prune ideological stuff" at universities and state agencies.

Our lawsuit against the FWC sends a clear message: the Constitution doesn't belong only to those in power. Free expression — especially speech that challenges authority — is the cornerstone of a free society. We're standing with Britt Brown, and with every Floridian who has been brashly targeted by state censorship.

More Legal Highlights:

- *Florida Immigrant Coalition v. Uthmeier -* In our case challenging the invented state-level "crimes" for people accused of improper entry, we gave oral argument on October 9 in the U.S. Court of Appeals for the Eleventh Circuit in Atlanta to defend our preliminary injunction putting the law on hold. We now await the appeals court's decision.
- *Vote! v. City of Daytona Beach* Represented by the ACLU of Florida, three local residents and a community membership organization, VOTE!, filed a federal lawsuit in mid-October challenging the map recently adopted by the Daytona Beach City Commission because the new map unlawfully ignored communities of interest and neighborhood needs in favor of impermissible racial goals. The lawsuit follows the City Commission's decision to redraw its map after resolving a <u>previous lawsuit</u> in January 2025 that challenged the City's first attempt to redistrict as illegally gerrymandered. We are proud to stand with Daytonans who are taking a stand to defend their democracy
- *Keohane v. Dixon* In our case challenging the denial of medically necessary gender-affirming care in Florida's prisons, the court granted in part our motion for class certification, meaning our case has officially been certified as a class action. The judge's ultimate ruling will have the potential to impact hundreds of transgender individuals in state custody as to certain aspects of their gender-affirming care.



GRASSROOTS POWER IN ACTION

This fall, our staff and volunteer teams showed up - on the ground, online, in small and large spaces all across the state. We hosted our first Power and Purpose: Fight For Reproductive Justice training in Orlando, where the community came together to learn how our legislators voted, fine-tune our organizing skillsets, build community, and take action for reproductive justice. We also hosted our virtual, volunteer-led Constitution in Crisis Series to review the countless human rights abuses and constitutional violations occurring within our detention facilities and to learn how to join the fight to shut them down.

Our volunteer team also showed up for No Kings Day, prepared to do the work. In Miami, we had our fearless Stronger Miami volunteers who collected ballot initiative petitions from City of Miami residents. Across counties in Tallahassee, Miami, Ft Lauderdale, Orlando, and St. Petersburg, our legal observers wore their vests with commitment and pride and ensured nothing was missed. These are just a few of the many ways supporters and volunteers are showing up across the state to make an impact. There are so many opportunities to join this fight —in person or virtually.

TURNING OUTRAGE INTO IMPACT



Honoring Civil Rights Heroes of the Past Through Legislation Today

The freedom to vote is the cornerstone of our democracy and the foundation for all of our rights. Without that foundation, all our other rights fall. In August, the nation celebrated 60 years since President Lyndon Johnson signed the Voting Rights Act into law. But the US Supreme Court has weakened the VRA over the last decade, making it much harder to protect the right to vote for all citizens regardless of race.

That's why in 2024, the ACLU of Florida worked with partner organizations and legislators to draft the strongest pro-voter legislation ever filed in Florida. We became the first state in the Deep South to file a state Voting Rights Act, and other states are following in our lead. We are thrilled to announce that the Florida VRA will soon be filed by legislative champions for a third straight legislative session.

Named after the first martyrs of the Civil Rights Movement – Harry T. and Harriette V. Moore – this bold legislation builds on work across the country to pass state-level VRAs and restore key provisions of the federal Voting Rights Act that have been weakened by the Supreme Court.

Harry and Harriette Moore were civil rights activists who helped to found the Brevard County chapter of the NAACP. Due in large part to their work, over 100,000 Black people were registered to vote in Florida – the most in the South. Unfortunately, the Moores paid the ultimate price for their advocacy when on Christmas Day 1951, members of the Ku Klux Klan bombed the Moore home in Brevard County. This bill honors their memory and their dedication to the sacred right to vote.

We are building a voting rights movement in Florida, and this is just the beginning of our advocacy. Stay tuned for ways to get involved this upcoming legislative session to support this and other movement-building legislation.

10,000 Petitions Collected for a Stronger Miami

We just hit a major milestone in our local campaign to increase voter turnout in Miami city elections, ensure local officials are accountable to the constituents they serve, and establish fair redistricting standards. Last week, Stronger Miami announced that it had collected 10,000 signed petitions! You can watch our campaign's latest video on <u>YouTube here</u>.

This milestone demonstrates what we already know: Miamians are ready for change and determined to build a government that truly listens, represents, and delivers. For decades, corruption and backroom power plays have plagued the City Commission and silenced the will of the people. Voters finally have a chance to change that and demand a government that works for us, not against us.

TURNING OUTRAGE INTO IMPACT

Miami Voters Deliver a Historic Win for Fair Representation

Miami just made history. On November 4, voters passed Referendum 3, a citizen-led reform that ends political gerrymandering in city elections and creates an independent Citizens' Redistricting Committee.

This victory proves what we already know: Miamians are ready for change and determined to build a government that truly represents every neighborhood and every voter. For too long, backroom map-drawing has divided our communities and diluted our voices. Now, residents have taken power back — demanding fairness, transparency, and accountability in how our city is governed.

With the passage of Referendum 3, we've taken a historic step toward a stronger Miami — one where every vote counts and every community has a voice at City Hall. This win belongs to the residents who organized, spoke out, and showed that when people lead, real change follows.

But we're not done yet. The Stronger Miami campaign is already building toward 2026, when voters will have the chance to pass a comprehensive City Charter Amendment to make local government more accountable, align elections with statewide cycles to boost turnout, and strengthen standards that keep special interests out of redistricting.

We need 20,000 verified petitions to get this city charter amendment on the 2026 ballot. We need every hand, every signature, and every voice. The time for change is now, and democracy can't wait.
