Courage is contagious. And in Florida, choosing courage over fear is how we protect our communities—and the future of our democracy.

As we close out this year, I find myself reflecting not only on what we've faced, but on what you've made possible. For 70 years, Floridians like you have shown that a single voice—raised at the right moment—can spark change that lasts.

This year, as we marked our milestone anniversary, we honored leaders of courage across our state. Their stories reminded us that courage has no political affiliation. It doesn't wait for permission. It comes from lived experience—and from the clarity that silence is never neutral.

We've seen courage up close this year: people stepping forward to defend rights in court; people using their time, resources, and platforms to push back against cruelty; and everyday Floridians speaking truth to power in city halls, school board meetings, and community spaces across the state.

Indeed, we are the frontline of resistance and the vanguard of courageous advocacy and activism that will make the vision of a Free Florida and Free Nation real.

#### **LEGAL UPDATE: WHERE JUSTICE MEETS RESISTANCE**

THE COURTS ARE A FRONTLINE AND WE'RE MEETING THE MOMENT WITH TRUTH AND COURAGE

Tallahassee is balancing its budget on the backs of its most vulnerable — and it's doing so unconstitutionally. A city may try to disguise an illegal tax as a "fee," but it cannot do so an end-run around our Florida Constitution. That's exactly what Tallahassee has done with its so-called fire services fee, quietly tacking it onto monthly utility bills and threatening residents with shutoffs, liens, collections, and even foreclosure if they don't pay.

This isn't a neutral policy mistake. It's a regressive scheme that hits hardest where people can least afford it. The flat, per-household charge disproportionately burdens low-income residents, renters, students, and Black and Hispanic households. Worse still, the city structured the fee into two zones: an inner zone that is more racially diverse and lower-income — and pays more — and an outer zone that is wealthier, whiter, and pays less. Same city. Same fire protection. Unequal cost.

Florida's Constitution is clear: local governments don't get to invent new taxes. Tallahassee knows this. That's why it labeled this charge a "fee" and slipped it into utility bills instead of going through the lawful, constitutional process required for taxation. It's unlawful, and it violates long-standing safeguards meant to prevent exactly this kind of abuse.

We've filed suit on behalf of Tallahassee residents and community advocates who refuse to accept a system where essential public services are funded by punishing the poor and entrenching racial inequity. Fire protection is a basic public good — not a revenue tool to be weaponized against struggling households.

This case is about more than a line item on a bill. It's about whether local governments are bound by constitutional limits, and whether residents are entitled to fair and equal treatment under the law. We're demanding an end to this unconstitutional tax — and accountability from a city that crossed the line.

#### More Legal Highlights:

- **Brown v. Young** In our case challenging a state biologist's dismissal for an indifferent social-media post concerning Charlie Kirk, the court denied the state's motion to dismiss the case. Our case is therefore continuing on an expedited track.
- *Lippe v. DeSantis* When Governor DeSantis failed to call a special election for a vacancy in Senate District 14 in violation of a statute that requires a special election to be called we filed suit. Then, in yet another victory in our string of victories in election-vacancy cases, the Governor called the election right before the state's response was due in our litigation.
- **Bettencourt v. Bryant** On November 21, we filed an amicus brief in the Eleventh Circuit advocating for the ability of inmates to bring lawsuits directly in federal court in certain circumstances, without having to go through the sometimes extremely burdensome administrative requirements of the Prison Litigation Reform Act.

#### Democracy Doesn't Draw Itself: What We're Fighting for in 2026

Voters should choose our elected officials—not the other way around. But Florida lawmakers are preparing to move forward with a partisan redistricting power grab that puts politicians' self-interest ahead of voters and our communities.

Floridians already said no to partisan gerrymandering. In 2010, voters overwhelmingly amended the Florida Constitution to ban drawing districts to favor a political party or incumbent—and we will keep holding lawmakers to that promise.

#### **Stop the Partisan Power Grab (December 2 Day of Action)**

On December 2, we stood with Equal Ground, the Southern Poverty Law Center, All Voting is Local, and Floridians from across the state to deliver a clear message to the Legislature: Stop the Partisan Power Grab. [Watch our remarks]

#### **Legislative Session Starts January 13**

Florida's 60-day Legislative Session begins January 13, and our team will be at the Capitol fighting for laws that protect and strengthen our civil liberties—and pushing back against attacks on our rights. <u>Sign up for our Legislative Town Hall Series</u> to stay up to date on the best and worst bills moving this session, and how you can take action.

#### **Blocking a Dangerous Anti-Abortion Bill (HB 289 / SB 164)**

During interim committee weeks, legislators attempted to fast-track a sweeping anti-abortion bill (HB 289 / SB 164) that would endanger health care and invite harassment and punishment. The bill would open the door to lawsuits seeking unlimited damages against health care providers—and even against friends and family members who help someone access care. It also attempts to treat fertilized eggs as people under Florida law, with far-reaching consequences. We're working with Planned Parenthood and partners to stop it. #### Stronger Miami: Two Major Milestones for Fair Representation

Our Stronger Miami campaign reached two incredible milestones:

- Miami voters passed <u>Referendum 3</u>, a citizen-led reform that bans political gerrymandering in city elections and establishes the City of Miami's first-ever Citizens' Redistricting Committee.
- The campaign also surpassed 15,000 petitions toward a comprehensive 2026 City Charter Amendment to strengthen accountability, boost turnout, and protect fair maps. [Learn more and get involved at StrongerMiami.org]

#### Standing Up to Attacks on Nonprofits and Targeted Communities
