Dear Sir,

Pursuant to the Florida Public Records Law, Chapter 119, Florida Statutes, the American Civil Liberties Union of Florida, Inc., (ACLU of Fla.) hereby requests current inmates' demographic, offense, and tentative release date information as well as information the Florida Department of Corrections ("FDOC") used to calculate the tentative release dates, as detailed below. We welcome the opportunity to answer any questions you might have about this request in order to better facilitate the production of the public records.

**PUBLIC RECORDS REQUESTED**

For each person in FDOC's current custody,<sup>1</sup> please provide an extract of FDOC's database(s) with the following fields:

1. FDOC number
2. Race (OBIS)
3. For each *current* offense for which the person is incarcerated (OBIS):
  - (a) Offense Date
  - (b) Date Adjudicated
  - (c) County
  - (d) Case Number
  - (e) Prison Term
  - (f) Adjudication Charge Description

- (g) Qualifier Description
  - (h) Adjudication Description
  - (i) Adjudication Charge's Florida Statute Subsection (Prison Commitment Code Sheet)
- 4. Date FDOC assumed custody over the person (OBIS: <ReceiptDate>)
- 5. Tentative release date (OBIS: <ReleaseDate>)
- 6. The following information from the database containing information from the "Overall Inmate Record" (DC-14):
  - (a) "Overall Term" of Incarceration
  - (b) Sentencing Guidelines Offense Level
  - (c) 85% Minimum Release Date
  - (d) Provisional Release Date
  - (e) Special Provision related to term of incarceration, e.g., "Parole Ineligible"
  - (f) Sentence Date (if different from OBIS <DateAdjudicated>)
  - (g) Date of "New Commitment" reflected in the Inmate Movement/Transfer History section (if different from OBIS <ReceiptDate>)
  - (h) Tentative Release Date (if different from OBIS <ReleaseDate>)
- 7. Each field or piece of information used to calculate the tentative release date and specifically the following:
  - (a) Term of incarceration of each current offense (e.g., OBIS <prisonterm>)
  - (b) Whether the term of incarceration of each current offense runs concurrent or consecutive with another term of incarceration for another offense
  - (c) Amount of county jail time credit<sup>2</sup> or other credits for confinement during or prior to commitment to FDOC
  - (d) Whether and why an offense is ineligible for gain time for a portion or the entire term of incarceration

- (e) Amount and type<sup>3</sup> of earned gain time
- (f) Amount of and reason for forfeited gain time<sup>4</sup>
- (g) Amount and type of gain time that might have been earned, but for (i) the 85% limitation in § 944.275(4)(f), Fla. Stat., or (ii) an offense being ineligible for gain time prior to serving the mandatory minimum sentence<sup>5</sup> or during the entirety of an offense's sentence.<sup>6</sup> *In the alternative, please provide (i) the months in which an inmate's evaluation, disciplinary confinement, or other reason would result in less than the maximum gain time credit and (ii) the reason.*



If the information is contained in more than one database, please provide an extract of the requested inmate-specific information in that database along with the inmates' FDOC number. Please provide any tables or crosswalks necessary to correlate extracted information that is not inmate specific. We request this database extract in an electronic format, preferable as a .txt, .csv., access, or excel file, whatever is most convenient for you. *See* § 119.01(2), Fla. Stat.

#### **INFORMATION ABOUT THE REQUEST**

**Acknowledgement:** As required by law, please acknowledge that you have received this public records request and provide an estimated timeframe in which you believe that you will be able to produce the requested records. *See* § 119.07(1)(c), Fla. Stat. ("A custodian of public records and his or her designee must acknowledge requests to inspect or copy records promptly and respond to such requests in good faith").

**Costs:** The ACLU of Fla. is a non-profit organization. Therefore, we request that you produce the requested records free of charge. However, if you are unable to do so, the ACLU of Fla. will reimburse you for the reasonable costs associated with fulfilling this

request, if your office has a policy of requiring the payment of a copying charge for such records. If you anticipate that the total costs associated with fulfilling this request will exceed \$300, please contact me with an estimate of the likely cost before proceeding.

**Justify Exemptions:** If you are unable or refuse to provide part or all of the requested public- records, please explain in writing and with particularity the reasons for not providing the requested public information in its entirety, as required by Section 119.07(1), Florida Statutes. If any exemption that you assert applies to only a portion of the records (as opposed to the entire record), please redact the portion you claim is exempt, provide copies of the remainder of the record or records, and detail your reasons for the modification as required by Section 119.07(1), Florida Statutes.

### **REASON FOR REQUESTED INFORMATION**

The ACLU of Fla. is concerned about the over-incarceration in our state as well as the racial disparity of those incarcerated. It hopes to propose an amendment to § 944.275(4)(f), Fla. Stat., to decrease the term a person with gain time must serve below the current “minimum of 85 percent” of the sentence. It wants to reduce the prison population and the percentage of incarcerated persons of color—not to mention reduce the over \$2 billion Floridians pay to incarcerate them. However, to propose meaningful legislation, the ACLU of Fla. needs to better understand the current prison population, how tentative release dates are calculated, and how amending legislation may affect them.

### **CAMPAIGN’S PREVIOUS REQUEST & RESPONSE**

The ACLU of Fla. is part of the Campaign for Criminal Justice Reform (“Campaign”). On Sept. 30, 2019, the Campaign for Criminal Justice Reform (“Campaign”) through Stephanie Kraft made a public records request pursuant to Ch. 119, Fla. Stat. *See* Exhibit A. Because the Campaign sought much of the same information the ACLU of Fla. now seeks, FDOC may similarly respond. We wish to avoid an unconsidered response.

The Campaign requested demographic information for and details of criminal offenses of currently incarcerated persons along



with information related to their duration of incarceration, gain time, and calculation of the release date.

The Public Records Request Unit (Roger Sockman) of FDOC initially explained that many of the information was available through the public OBIS Database ([http://www.dc.state.fl.us/pub/obis\\_request.html](http://www.dc.state.fl.us/pub/obis_request.html)). However, Mr. Sockman accurately stated that the OBIS database does not contain the (a) statute reference, (b) gain time, or (c) jail credit. FDOC initially took the position that because these fields are “not available in any existing report,” it was relieved of any duty to provide this information. When the Campaign reiterated its request for inmates’ gain time, FDOC conceded the information was available. It proposed that the Campaign request a “DC-14 screen shot”<sup>7</sup> for each incarcerated inmate, which would total nearly 97,000. However, such a request—to say nothing of FDOC’s burden of providing 97,000 individual records—defeats public access. We see a better way forward.

#### ACCESS TO INFORMATION IN A DATABASE

The Florida Constitution’s public-access mandate (art. 1, § 24) applies to information in electronic databases.<sup>8</sup> The information in FDOC’s database(s) was “prepared in connection with official agency business,” and is “intended to perpetuate, communicate, or formalize knowledge,” and thus is subject to public access. *See Shevin v. Byron, Harless, Schaffer, Reid & Assocs., Inc.*, 379 So. 2d 633, 640 (Fla. 1980).

## **FDOC Maintains Requested Information in Database**

FDOC maintains this requested information in one or more electronic databases. Its OBIS database includes each inmate's (2) race, (3) offense information, (4) date remanded to FDOC custody, and (5) tentative release date information.<sup>9</sup> *See* OBIS Database—Contents of Selected Tables, Exhibit B. FDOC maintains in a database the (6) information presented on the “Overall Inmate Record” (DC-14), *see, e.g.*, Exhibit C.

Furthermore, FDOC maintains information in a database used to calculate the tentative release date. FDOC must calculate a tentative release date for each inmate. § 944.275(3)(a), Fla. Stat. This release date is determined from a number of factors, many of which are initially entered into a database from a Prison Commitment Code Sheet (Form DC4-310) (or currently used similar form), *see, e.g.*, Exhibit D, including (7)(a) term of incarceration for each offense, (7)(b) whether the term runs concurrent or consecutive with another offense sentence, (7)(c) any county jail time credit, (7)(d) whether and why the offense is ineligible for gain time for a portion or all of the term of incarceration, and (3)(i) the violated section of Florida Statutes.

Each month, FDOC updates its database with 7(e) gain time (amount and type) recently earned. This information is displayed in the Overall Inmate Record (DC-14). Furthermore, to calculate tentative release dates in OBIS, FDOC would have to account for 7(f) gain time (amount and reason) recently forfeited. Over 25,000 inmates earn gain time each month. Accordingly, FDOC undoubtedly has automated this record-keeping and amendments to the tentative release date—prison officials only note only when an inmate's security and performance evaluations were unsatisfactory or other permissible reasons.<sup>10</sup> Thus, instead of noting when an inmate receives gain time, FDOC's database naturally reflects when an inmate does not receive full gain time. We also seek this information too. *See* Request, *supra*, No. 7(g)

## **Database Architecture**

Database architecture stands in contrast to traditional public-record media. Unlike, for example, a book, the information in a database has no innate organization. Instead, information is only organized and presented once dictated by the user. Consider a *printed* copy of the white pages that is organized by last name. Re-sorting it by first name would be difficult. However, a white-pages *database* has no inherent organization. Thus, a user may view the directory by last name—or just as easily by first name, street address, or telephone number. Furthermore, the user may decide to present only some of the information. For example, the user may decide to exclude the person’s first name and address—presenting only last name and telephone number. Or the user may decide only to present details about persons whose last name begins with “A.” Or the user may decide to present details of all persons who live at a street address that includes the word “Main.”<sup>11</sup> Ultimately, to present information in a database, the user must decide what and how to present it. The database has no understandable form before these decisions are made—before the computer is instructed by a person.

FDOC decides what and how information is presented on its web-based Offender Information Search (<http://www.dc.state.fl.us/OffenderSearch/Search.aspx>), *see, e.g.*, Exhibit E, and through the OBIS Database ([http://www.dc.state.fl.us/pub/obis\\_request.html](http://www.dc.state.fl.us/pub/obis_request.html)). Its portals permit the public access to *some* information FDOC has—but it controls what and how the information is shared. For example, FDOC’s database may contain an inmate’s social security numbers, but it takes care to ensure that information is not publicly available. Furthermore, FDOC undoubtedly has developed reports that present an extract of selected information in its database(s) that it uses internally. For example, prison officials can pull up an inmate’s details with an Overall Inmate Record (DC-14) query.

In each case, FDOC *chooses* what information to present and how to organize it. However, equally true, FDOC could have just as easily chosen to present other information. It makes no difference to the computer. For example, FDOC could have included in the OBIS Database the overall term of incarceration, amount of jail time credit, and whether an offense was ineligible for gain time. That FDOC does not have a *current* list, extract, or report says nothing of whether it could easily generate one. The user, not the database, controls what and how information is presented.

When using multiple databases, FDOC can choose to link or “crosswalk” them to create an extract information from each database. Because the inmates FDOC number is uniform, it may link databases by this number or “field.” Returning to the white-pages example, if a database-owner has two lists—one of home telephone numbers, one of mobile telephone numbers—it may link them by the subscriber’s name. In this way, it could easily create a report or extract that lists each subscriber’s name, home number (if any), and mobile number (if any). The database-owner’s objection that information is maintained in two databases would fail because information from each may be extracted in a single list. Thus, even if FDOC maintains a gain time database separate from an inmate database, FDOC can extract and present information from both by linking them by the inmate’s FDOC number.<sup>12</sup>

Thus, FDOC can provide the requested information in a meaningful form. Unquestionably, FDOC could provide an extract of the database that lists for each inmate the “Overall Term of Incarceration” field it displays in the Overall Inmate Record (DC-14). It does not need to actually print nearly 97,000 forms. Similarly, it could provide an extract of the fields that are used to calculate tentative release date, without providing thousands of printouts of select information on gain time for each individual.

For example, in response to the ACLU of Florida’s public records request, in 2013 FDOC provided the bed assignments for each inmate in Santa Rosa CI on Nov. 10, 2013. *See* Exhibit F. FDOC did not need to produce, for example, thousands of Overall Inmate

Records (DC-14) (which includes the inmates' bed assignments) for each of the nearly 2,000 inmates in the prison. Instead, this information was easily extracted from the same database used to display an individual inmate's Overall Inmate Record. Clearly, FDOC can provide an extract of a database that it maintains.

### **Meaningful Access**

For these reasons, FDOC's response to the Campaign's public records request misunderstands FDOC's constitutional mandate with respect to public information in its database. FDOC may not deny meaningful access to public information by throwing up its hands and saying the requested information is "not available in any existing report." The law does not permit FDOC to control what and how information from its database(s) is accessible by only offering limited displays or fields. Otherwise, public access to information in a database would be limited to the information FDOC previously *chose* to include in an extract. FDOC cannot conceal public information by simply choosing not to create a list that presents it.

Equally, it cannot undermine a reasonable request for information by providing nearly 97,000 individual Overall Inmate Records, which would require countless hours to extract the information into a useable form. When FDOC can easily produce the same information in a meaningful format, it cannot obstruct public access with a dismissal that the information exists in a haystack of paper. Returning to the white-pages example, a database-owner cannot merely produce a book in response to a request for a list of subscribers who live on Main Street and leave it to the public to flip pages and hunt for the answer. When the database-owner could easily present a list of subscribers whose street address includes "Main," it must do so. Thus, FDOC defeats meaningful access when it expects the public to expend substantial time searching and correlating information that FDOC could provide in a meaningful form in a matter of hours. We trust it will not make the same response here.

The ACLU of Fla.'s request does not require the creation of a new record. FDOC's databases already exist. The ACLU of Fla.'s request does not require the reorganization of a record. FDOC's databases have no inherent organization; a user must decide what and

how its information is presented. The ACLU of Fla. simply requests meaningful access to public information.

“The purpose of the Public Records Act is to promote public awareness and knowledge of governmental actions in order to ensure that governmental officials and agencies remain accountable to the people.” *Forsberg v. Housing Authority of the City of Miami Beach*, 455 So. 2d 373, 378 (Fla. 1984); *see also Citizens United v. Federal Election Com’n*, 558 U.S. 310, 339 (2010) (“The right of citizens to inquire, to hear, to speak, and to use information to reach consensus is a precondition to enlightened self-government and a necessary means to protect it.”). The Campaign and now the ACLU of Fla. seek information about how the current laws about gain time affect who is imprisoned and for how long. Only with this information can Floridians begin a constructive discussion about how to create a smart justice system for Florida and a more perfect union.
