ACLU'S MOTION FOR SUMMARY JUDGMENT

Pursuant to Fla.R.Civ.P. 1.510, Plaintiff American Civil Liberties Union of Florida, Inc. ("ACLU" or "Plaintiff") requests summary judgment against Defendant Florida Department of Corrections ("FDOC" or "Defendant") and states as follows in support of this motion:

I. Introduction

The ACLU is concerned about the over-incarceration in our state as well as the racial disparity of those incarcerated. It hopes to propose an amendment to § 944.275(4)(f), Fla. Stat., to decrease the term a person with gain time must serve below the current "minimum of 85 percent" of the sentence. It wants to reduce the prison population and the percentage of incarcerated persons of color—not to mention reduce the over \$2 billion Floridians pay to incarcerate them. However, to

propose meaningful legislation, the ACLU needs to better understand the current prison population, FDOC's calculations of tentative release dates, and how amending legislation may affect them. To that end, it sought access to public records.

The Florida Constitution provides the public the right to access to public records. Fla. Const., art. I, § 24. "The purpose of the Public Records Act is to promote public awareness and knowledge of governmental actions in order to ensure that governmental officials and agencies remain accountable to the people." Forsberg v. Hous. Auth. of the City of Miami Beach, 455 So. 2d 373, 378 (Fla. 1984). Public access is a "cornerstone of our political culture." Bd. of Trs., Jacksonville Police & Fire Pension Fund v. Lee, 189 So. 3d 120, 124 (Fla. 2016). The ACLU seeks access to public information to propose meaningful amendments to Florida's laws governing gain time and participate in our representative government. Only with this information can Floridians begin a constructive discussion about how to create a smart justice system for Florida and a more perfect union.

II. STATEMENT OF FACTS

1. On Feb. 12, 2020, the ACLU requested FDOC provide the ACLU with "any record (or a sufficient combination of records) that reflects the formula or calculation FDOC uses to determine inmates' tentative release dates pursuant to

§ 944.275(3)(a), Fla. Stat." Answer (filed June 23, 2020), ¶ 16; Records Request: Tentative Release Date Formula (Public Records Request No. 19-0860), attached to Complaint, at 10.

- 2. On Feb. 13, 2020, the ACLU requested FDOC provide the ACLU with "any record (or a sufficient combination of records) that reflects the formula or calculation FDOC uses to determine inmates' "Overall Term" (prison term) reflected in the DC-14." Answer, ¶ 17; Records Request: Overall Term Formula (Public Records Request No. 19-0865), *attached to* Complaint, at 11.
- 3. The requested formulas (or combination of formulas) exist in some form. Answer, ¶¶ 29-30.
- 4. FDOC calculates a tentative release date for each inmate. *See* § 944.275(3)(a), Fla. Stat. (mandating FDOC to calculate a tentative release date for each inmate).
- 5. FDOC calculates an overall term for each inmate. *See* Exemplar FDOC's "Overall Inmate Record" (Form DC-14), attached, *infra* at 9.
- 6. Defendant Florida Department of Corrections ("FDOC") is a department of the Florida State government and an "agency" as that term is defined in § 119.011(2), Fla. Stat. Answer, ¶ 5.

7. FDOC has not provided the requested formulas. Answer, ¶ 26.

III. ARGUMENT

The ACLU is entitled to summary judgment as a matter of law based on the undisputed facts. To prevail in a Public Records lawsuit, the plaintiff must "prove they made a specific request for public records, the [agency] received it, the requested public records exist, and the [agency] improperly refused to produce them in a timely manner." *Grapski v. City of Alachua*, 31 So.3d 193, 196 (Fla. 1st DCA 2010), *cited with approval in O'Boyle v. Town of Gulf Stream*, 257 So. 3d 1036, 1040 (Fla. 4th DCA 2018). The undisputed facts and law establish the ACLU satisfied each of these elements:

FDOC admits that the ACLU requested FDOC provide its tentative release date and overall term formulas and that FDOC received those requests. Answer, ¶¶ 16 & 17. Other predicate facts are also uncontroverted. FDOC is an "agency," § 119.011(2), Fla. Stat. Answer, ¶ 5. As such, FDOC is required to comply with the Public Records Law and has a duty to provide access to public records. *Id.*; § 119.01(1), Fla. Stat.; § 119.07(1)(a), Fla. Stat.; § 119.07(1)(a), Fla. Stat. The ACLU has a right to access public records. Answer, ¶ 28; Art. I, § 24(a), Fla. Const., § 119.01(1), Fla. Stat.; § 119.07(3)(a), Fla. Stat

FDOC's only defense is that formulas are not "public records" and they are otherwise exempt from disclosure. *See* Answer, at 4. Yet, its defense fails as a matter of law.

The formulas are public records.

Florida broadly defines a public record as any material "made or received" "in connection with the transaction of official business by any agency." § 119.011(12), Fla. Stat. The tentative release date and overall term formulas exist in "some form." Answer, ¶ 29-30. The formulas "perpetuate" or "formalize" knowledge, *Shevin v. Byron, Harless, Schaffer, Reid & Assocs., Inc.*, 379 So.2d 633, 640 (Fla. 1980), about how the FDOC should and does calculate the tentative release date and overall term from other data points, including length of sentence and conviction date. FDOC uses the formulas and thus "made or received" them to carry out its official business. Indeed, FDOC is statutorily obligated to calculate a tentative release date for each inmate. § 944.275(3)(a), Fla. Stat. It regularly calculates the overall term to populate an inmate's "Overall Inmate Record" (Form DC-14), *infra.* at 9. Therefore, the formulas are "public records."

The formulas' form is irrelevant. § 119.011(12), Fla. Stat. (defining broadly "public records" to include all "material, regardless of the physical form, characteristics, or means of transmission"). It matters not whether the formulas are embedded in computer software or code. They are still public records. *Id*.

(defining "public records" to include "data processing software"); see also § 119.01(2)(a), Fla. Stat. ("each agency must provide reasonable public access to records electronically maintained" and "[a]utomation of public records must not erode the right of access to those records"); Rhea v. Dist. Bd. of Trustees of Santa Fe Coll., 109 So. 3d 851, 855 (Fla. 1st DCA 2013) ("The physical format of the record is irrelevant; electronic communications, such as e-mail, are covered just like communications on paper."); Nat'l Collegiate Athletic Ass'n v. Associated Press, 18 So. 3d 1201, 1207 (Fla. 1st DCA 2009) (observing that "public records law is not limited to paper documents but that it applies, as well, to documents that exist only in digital form").

The formulas are public records subject to the Florida Public Records Law.

No exemption applies.

FDOC has asserted a single exemption applies. § 119.07(1)(e), Fla. Stat. (requiring agency to specify basis for any public record exemptions). FDOC asserts that the formulas are "security or firesafety system plans" that could compromise the physical security of a government facility. Answer, at 4. The Court should reject FDOC's novel reading of this exemption.

Florida law exempts from public disclosure security or firesafety system plans. § 119.071(3), Fla. Stat.; *see also* § 281.301, Fla. Stat. These security plans

broadly include records that concern or would compromise the "physical security or firesafety of [a] facility," like threat assessments, evacuation plans, and manuals for security equipment. § 119.071(3)(a)(1), Fla. Stat.

This exemption is inapplicable to the ACLU's request for release-date formulas. The ACLU does not seek information about a facility or its security. How FDOC calculates tentative release dates or overall terms cannot possibly compromise FDOC's ability to safely and securely detain persons. Indeed, the release dates themselves are published for every inmate online for any member of the public to review at any time. If the release date itself is public, it defies reason to suggest that manner in which the date is calculated could compromise the physical security or firesafety of a facility. The security plan exemption does not provide FDOC with a blanket excuse to refuse to provide any information about its workings and thereby evade accountability. It should be rejected.

WHEREFORE, the ACLU requests summary judgment against FDOC.
