**ACLU MOTION TO COMPEL DISCOVERY**  
(Overall Inmate Records)

Pursuant to Fla.R.Civ.P. 1.380, American Civil Liberties Union of Florida, Inc. (“ACLU”) requests an order compelling Florida Department of Corrections (“FDOC”) to provide the requested Overall Inmate Record (DC-14) for 27 persons incarcerated by FDOC. FDOC’s Resp. to Request for Documents (filed Mar. 5, 2021), No. 6, *infra* at 18-20.

**A. Background**

In the fall of 2019, the ACLU sought access to “[e]ach field or piece of information used to calculate the tentative release date,” held in FDOC’s database(s). Records Request (filed Nov. 19, 2019), at 2, ¶ 7. When FDOC did not provide public access, the ACLU sued.

On Jan. 14, 2020, FDOC belatedly provided the ACLU with 4 interrelated datasets (text (“:txt”) files) along with supporting tables describing codes used in those datasets, collectively “datasets.” FDOC assures everyone these datasets completely satisfy the ACLU’s request—they meaningfully provide the information it uses to calculate the tentative release dates and FDOC has nothing further. FDOC’s Resp. (Jan. 31, 2020), ¶ 1. Yet, the ACLU raised numerous questions about the datasets’ integrity, completeness, and descriptions. ACLU Reply (Feb. 5, 2020). This Court permitted discovery to flesh out these concerns. Order Permitting Discovery (June 10, 2020).

### **B. Overall Inmate Record (DC-14)**

We begin with an explanation of how the Overall Inmate Records are “relevant to the subject matter of the pending action.” Rule 1.280(b)(1).

The Overall Inmate Record contains many pieces of information necessary to calculate the tentative release date. For example, the Overall Inmate Record details the current offenses for which the person is serving time. *See* Overall Inmate Record (FDOC No. C02777), *infra* at 21. Some of this information in the Overall Inmate Record was *included* on Jan. 14, 2020, in its provided datasets. At the same time, FDOC’s datasets also *exclude* other information found in the Overall Inmate Record necessary to calculate the tentative release date. The ACLU requested the Overall Inmate Records to establish FDOC has the

information *included* in the Overall Inmate Records necessary to calculate the tentative release date that is *excluded* from the datasets FDOC.

The specific information necessary to calculate the tentative release included in the Overall Inmate Record, but excluded from the datasets, includes the following. Thus, collecting and examining the Overall Inmate Records will enable the ACLU to establish FDOC has information, but excluded it from its datasets, that is necessary to calculate the tentative release date.

#### 1. Forfeited Gain Time

Gain time may be forfeited. § 944.28(2)(a), Fla. Stat. (“All or any part of the gain-time earned by a prisoner ... is subject to forfeiture if such prisoner ... violates any rule or regulation of the department”); Fla. Admin. Code Ann. r. 33-601.104(1)(b). And the tentative release date changes when gain time is forfeited. § 944.275(3)(a), Fla. Stat. Thus, Forfeited gain time must be considered when calculating the tentative release date.

The Overall Inmate Record reflects forfeited gain time. Overall Inmate Record (FDOC No. C02777), *infra* at 23 (reflecting a forfeiture on Mar. 18, 2021, of 164 days for unauthorized possession of a cell phone). Yet, although FDOC’s provided GNTMOUT.txt dataset includes *earned* gain time, no dataset includes any *forfeited* gain time. *See* ACLUDWNLD.docx, *infra* at 38-39.

## 2. Mandatory Minimums Amounts (Isaac Harris)

At times, a person is ineligible to receive gain time during a portion or the complete sentence for an offense. For example, the 10-20-Life law sets mandatory minimum sentences for certain enumerated offenses based on the possession or use of a firearm. § 775.087(2)(a), Fla. Stat. A person serving a 10-20-Life sentence is “not eligible for statutory gain-time ... prior to serving the minimum sentence.” § 775.087(2), Fla. Stat. The law prescribes different mandatory sentences, depending on whether the guns is discharged (20 years), discharged with the result of great bodily harm (25 years), or merely possessed (10 years). *Id.* Thus, simply knowing whether a person’s sentence was subject to the 10-20-Life mandatory minimums says little about the applicable mandatory minimum. The period of ineligibility (e.g., the mandatory minimum sentence) must be considered when calculating the tentative release date.

The Overall Inmate Record reflects the imposed mandatory minimum sentence pursuant to 10-20-Life. Overall Inmate Record (FDOC No. C02777), *infra* at 21 (reflecting a 10-year for the mandatory minimum sentence imposed on Oct. 21, 2008, pursuant to the “Firearm” special provision). Indeed, FDOC “code[s]” and enter[s]” into its Offender Based Information System (OBIS) each offense’s special provisions, including “Firearm” special provisions, and corresponding mandatory minimum sentence on the Prison Commitment Code

Sheet (Form DC3-310), *infra* at 40. Yet, although the SPCPOUT.txt dataset, which was provided by FDOC, notes the special provision “Firearm” code, no dataset includes the duration of the mandatory minimum. *See* ACLUDWNLD.docx, *infra* at 38-39. And without the actual mandatory minimum, it may be impossible to say simply from a “Firearm” special provision whether it was 10, 20, or 25 years.

### 3. Previously Served Time (Donald Cox)

At times, a person may serve a prison sentence, be released on probation, and then violate probation. When this happens, the “the trial court may impose any sentence the court ‘might have originally imposed.’” *Jacoby v. State*, 215 So. 3d 168, 171 (Fla. 2d DCA 2017) (quoting *Young v. State*, 697 So.2d 75, 77 (Fla. 1997)); § 948.06(2)(e), Fla. Stat. Yet, “credit for [previous] time served” offsets the new sentence. *Jacoby*, 215 So. 3d at 171. This is what happened to Donald Cox.

Cox’s Overall Inmate Record reflects both a “prior incarceration” and a “current incarceration” for the same lewd and lascivious offense imposed in Charlotte County, Case No. 2005 CF 717. Overall Inmate Record (FDOC No. Y29218), *infra* at 31. Under the prior incarceration heading, it shows Cox was originally sentenced on Aug. 12, 2005, to 5 years, 4 months, and 15 days. *Id.* He was released from prison on March 2, 2010. *Id.*; *see also id.*, *infra* at 32. Thus, he

served 1,663 days or ~4.5 years (March 2, 2010 – Aug. 12, 2005). He was released on probation, *infra* at 32.

Cox then violated probation. On Jan. 29, 2016, the trial court resentenced him to 11 years. *Id.*, *infra* at 31 (“Current Incarceration”). FDOC gave Cox these ~4.5 years as “credit for time served.” *Jacoby*, 215 So. 3d at 171. Thus, the tentative release date (Jan. 10, 2021) in his Overall Inmate Record, *infra* at 31, is not roughly 11 years after the 2016 sentence date (in year 2026 or 2027), but closer to 5 years (11 – 4.5 years for credit for time previously served), with additional jail credits and gain time shoring up the difference.

Details about the previously served prison sentence (e.g., the length of the prison sentence for which the person receives “credit for time served”) must be considered when calculating the tentative release date. This information is included in his Overall Inmate Record. It is excluded from FDOC’s datasets. FDOC failed to provide any information about the *previous* incarceration’s time served, jail credits, sentence dates, or release dates. *See* ACLUDWNLD.docx, *infra* at 38-39. Without this information, the tentative release date cannot be calculated.

#### 4. Out of Custody Time

At times, a person is released from FDOC custody to community supervision or escapes. Control Release, § 947.146, Fla. Stat., is an example. It is an early release program that is “activated by prison overcrowding.” *Rivera v. Singletary*, 707 So. 2d 326, 327 (Fla. 1998). Persons released on Control Release are release FDOC from custody to the Control Release Authority. § 947.146(13), Fla. Stat. Because they are not incarcerated by FDOC during community supervision, when Control Release is revoked, they do not receive any credit for the period community supervision toward the original sentence. § 947.141(4), Fla. Stat. Instead, they are “return[ed] ... to serve the sentence imposed.” *Id.*

On information and belief, the Overall Inmate Record reflects the “Control Release Actions.” Overall Inmate Record (FDOC No. C02777), *infra* at 24. The Overall Inmate Record likely reflects any period during which a person is released from FDOC and incarceration to community supervision.

For example, Bobbeth Morgan’s (FDOC No. I53158) Overall Inmate Record, *see* Request for Documents, No. 5(w), *infra*, at 16, would likely provide information about any Control Release of Morgan. Afterall, she FDOC assumed custody of her (Initial Receipt Date) on Mar. 20, 2017, to serve a 4½-year sentence (Prison Sentence Length). FDOC’s Corrections Offender Network, FDOC No.

I53158, *infra* at 41-42.<sup>1</sup> Adding the sentence term to the reception date—and even assuming no gain time and no jail credits—FDOC should not incarcerate her after Sept. 17, 2021. Yet, FDOC’s current tentative release date is in May 2022. Her Overall Inmate Record might explain why she has not received credit of serving her sentence for the entire 5½-year period between her sentence date (Sept. 6, 2015) through today. It might explain how she cited for speeding in Broward County on July 6, 2018. Traffic Citation, *infra* at 43.

FDOC failed to provide any information about periods of community supervision or otherwise was out of custody *after* FDOC’s initial custody of a person. See ACLUDWNLD.docx, *infra* at 38-39. Without this information, the tentative release date cannot be calculated because that period is excluded from the person’s service of a prison sentence. § 947.141(4), Fla. Stat.

### **C. Request for Production No. 6**

The ACLU requested 27 Overall Inmate Records to build its case that FDOC has not produced “[e]ach field or piece of information used to calculate the

tentative release date,” held in FDOC’s database(s). Records Request (filed Nov. 19, 2019), at 2, ¶ 7. It sought:

6. Current Overall Inmate Record (DC-14) for each person with the following FDOC Inmate Nos.: (subparts omitted).

Request for Production No. 6, *infra* at 18-19. FDOC refused to provide the Overall Inmate Records, raising 4 objections. *Id.* It begins with the generic objection—(a) the inquiry is “overbroad, vague, burdensome, and is not reasonably calculated.” *Id.* Additionally, it asserts that the (b) discovery is “inconsistent with ... Chapter 119.” *Id.* FDOC also argues (c) the request for production “on its face calls for legal conclusions and/or attorney.” *Id.* Lastly, it argues (d) the “information demanded” may only be provided in an in camera evidentiary hearing. *Id.* These objections are considered in turn.

(a) FDOC says the request is “overbroad, vague, burdensome, and is not reasonably calculated.” *Id.* But it is hard to see why and FDOC does not explain. Furthermore, the request for production is limited to specific information germane to this lawsuit—whether the provided data is complete and meaningful. FDOC’s unsupported objection should be rejected.

(b) Chapter 119 defines the right and scope of public access to agency records. However, it does not limit discovery in a lawsuit to enforce that right.

Instead, the Florida Civil Rules of Procedure define the scope of permitted discovery. Fla.R.Civ.P. 1.280 permits discovery on disputed facts. FDOC says it provided all of the data necessary to calculate the tentative release date. The ACLU disputes its completeness, integrity, and meaningfulness. These are factual disputes that will be at issue in the trial. The ACLU has a right to discover information about these disputes. An agency cannot simply say “trust us, we have no further records,” when the external facts and internal inconsistencies make clear that it is inaccurate. Chapter 119 cannot defeat reasonable discovery into an agency’s assurances. An agency cannot provide some public records and then refuse to answer questions that probe whether this is indeed true.<sup>2</sup>

(c) The Overall Inmate Records are not attorney-work product. They are agency records kept in the normal course and were not created by an attorney for litigation. Accordingly, disclosing them would not evade the “mental impressions” of FDOC’s counsel. *Hickman v. Taylor*, 329 U.S. 495, 510 (1947). The ACLU

<sup>2</sup> Additionally, seeking the Overall Inmate Records through a public records request is not a reasonable alternative. FDOC has not failed to respond to the ACLU’s pending, simple request in nearly 3 months.

On Dec. 17, 2020, and through FDOC’s online Public Records Center, the ACLU submitted a public records request for the Overall Inmate Record for 5 persons whose Overall Inmate Records were requested in Request for Documents, No. 5(o-r, t), *infra*, at 16. Records Request, *infra* at 44-46. Despite two follow inquiries about the status of the records request, FDOC has yet to provide the requested public records. *Id.*, *infra* at 45-46.

does not seek “[p]ersonal views” about the probative value of documents that will not be used at trial. *Northup v. Acken*, 865 So. 2d 1267, 1270 (Fla. 2004). The attorney-work product is inapplicable.

(d) No Public Records Law exemption applies to the Overall Inmate Records. FDOC has not claimed any exemption. It routinely provides them in response to records requests. Thus, no in camera hearing is necessary to assess the appropriateness of a claimed exemption because FDOC neither asserted an exemption nor does one exist.

#### **D. Reasonable Attorney’s Fees**

If a moving party prevails on a motion to compel, absent exceptions the court “shall require the [opposing] party ... to pay to the moving party the reasonable expenses incurred in obtaining the order that may include attorneys’ fees.” Rule 1.380. No exception applies. The ACLU’s counsel conferred with FDOC’s counsel in a good faith attempt to resolve this dispute without court action. FDOC’s refusal to provide discovery and opposition to this motion was not substantially justified. An award of expenses is just.

U.S. District Court Judge Walker recently approved an hourly rate for Stevenson of \$525. *Prison Legal News v. Inch*, 4:12CV239-MW/CAS, 2019 WL 5394614, at \*3-4 (N.D. Fla. Oct. 22, 2019) (noting Stevenson’s request for \$525/hour and finding “Plaintiff’s proposed rates to be reasonable”).

### **DECLARATION**

**RESPONDENT DEPARTMENT OF CORRECTIONS'**  
**RESPONSES TO ACLU'S THIRD COMPOSITE DISCOVERY REQUESTS**

Defendant FLORIDA DEPARTMENT OF CORRECTIONS ("FDOC"), by and through undersigned counsel, hereby responds to Plaintiff AMERICAN CIVIL LIBERTIES UNION OF FLORIDA, INC.'s, Third Composite Discovery Requests. In response thereto, Defendant would answer as follows:

6. Current Overall Inmate Record (DC-14) for each person with the following FDOC Inmate Nos.: (subparts omitted)

RESPONSE: Objection. This request is overbroad, vague, burdensome, and is not reasonably calculated to lead to the discovery of admissible evidence and is beyond the scope of Chapter 119. This request has no bearing on, or is inconsistent with, anything Chapter 119 requires to be produced or to the public records request at issue.

Unless exempt or confidential, the requested information must be provided in the manner in which it is kept at the Department. That is all that is required by Chapter 119. Any explanation or interpretation beyond that is outside the scope of Chapter 119. *See Fla. A.G.O. 92-38; In Re Report of the Sup. Ct. Workgroup on Public Records*, 825 So. 2d 889,898 (Fla.

2002); § 119.01(1), F.S. (“ It is the policy of this state that all state, county, and municipal *records* are open for personal inspection and copying by any person. Providing access to public *records* is a duty of each agency.”) (emphasis added).

Additionally, the interrogatory on its face calls for legal conclusions and/or attorney work product.

Further, it is the Department’s position that the information demanded to be produced by ACLU in this case is protected information by Florida Statute and that an *in camera* evidentiary proceeding will be the appropriate procedural mechanism for the Court to determine whether the information requested exists and/or is confidential or protected. The Department has previously filed motions for protection of this same or similar type of information, which are incorporated herein by this reference. The parties have agreed that the most efficient way to deal with the several outstanding discovery issues that currently exist in these consolidated cases is, subject to any determination by the court to the contrary, that all outstanding discovery matters if possible should be dealt with at the March 15, 2021. Until those motions and those objections are heard, no further discovery should be had.
